## "Who Do I Look Like?" DEVELOPING IDENTITY AS AN ADOPTEE

The formation of identity is a process that begins at puberty and continues through young adulthood. It has been defined as "achieving a cohesive definition of self while individuating from parents or family" (Grotevant). During identity formation, individuals explore and make commitments to roles and ideals while negotiating the balance between autonomy and their relatedness within the family, with peers, and other social relationships. As part of this process, individuals consider information told to them by others regarding who they are, where their strengths and weaknesses lie, how to behave, etc. They also look to those around them with whom they can identify in both physical features and natural abilities and discern if that is someone they can emulate.

Identity formation is an important developmental task in which all individuals engage; however, there is added complexity for the adoptee. Adoptees know (or should know) that they have a family of origin that differs from their adoptive one. Nearly all adoptees have attributes that are different than their adoptive family. These may include different ethnic and cultural orientations, personalities, appearances, health constitution, and physical and cognitive abilities. These differences, along with unclear or little information about their first family, may complicate the process of identity development for adoptees. Unclear or unknown characteristics of their family of origin may result in identity confusion and a postponement of other identity work. Working through these challenges is important for an adoptee's self esteem and overall wellbeing. The identity development process is one of "simultaneous

reflection and observation" in which an individual engages in critical judgments of himself and of society from multiple perspectives. Often missing for the adoptee to factor in as part of this process is a relationship with, or information about, their first family. Therefore, when grappling with identity, they are at a loss and uncertain as to whom or what to commit, as their adoptive families are their only history. While they may be attached and in a loving relationship with their adoptive family, something is "missing," and as a result, their strive for autonomy or independent identity may be hindered or laden with conflict.

Recognizing this is a first step in helping your child who has been adopted meet the challenge of attaining self-identity. It is very beneficial to the process that adoptive parents share as much information as possible about their child's biological family, including racial, ethnic and cultural factors that influence strengths and challenges. If nothing is known about the biological family, a parent may note the child's features and talents and suggest that they may be those which they inherited. If feasible, conversations should include the option of search and reunion, revisiting it from time to time even if the child's initial response is disinterest. If a mutual decision to search is made, it is best to work with a mental health professional. Search and reunion is multifaceted, and it is important to process expectations and to consider a range of outcomes. One needs to be sure they are emotionally prepared and to seriously consider appropriate timing as well as social and emotional impact on all family members.


"The Unspoken Trauma: Loss"

### **2022 Adoption Tax Credit**

For adoptions finalized in 2022, there is a federal adoption tax credit of up to \$14,890 per child. The 2022 adoption tax credit is not refundable, which means taxpayers can only use the credit if they have federal income tax liability.

The credit applies one time for each adopted child and should be claimed when taxpayers file taxes for 2022.


### **CPFA Book Group - April 27th**

Through all of it, he reckons with his own invisibility in a popular culture where even the superheroes have abandoned rural people in favor of cities.

Many generations ago, Charles Dickens wrote *David Copperfield* from his experience as a survivor of institutional poverty and its damages to children in his society. Dickens is not a prerequisite for readers of this novel, but he provided its inspiration."
